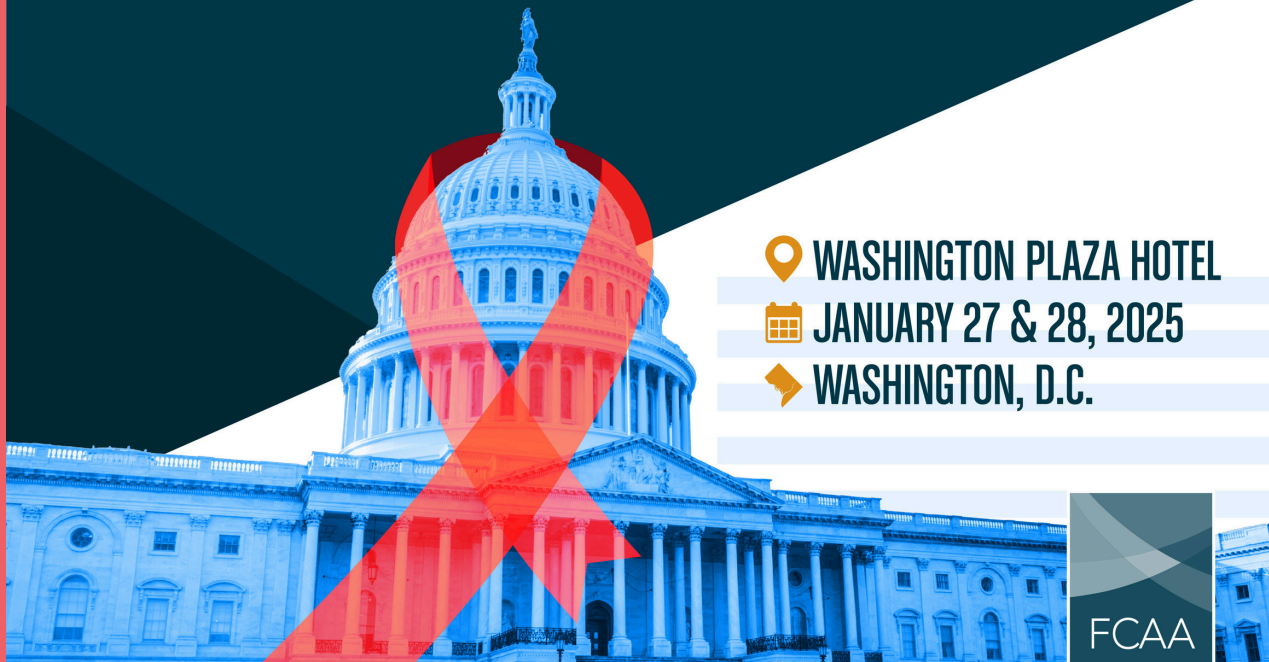

Dear Colleagues,

We stand at a pivotal moment in the fight against HIV. Two decades ago, the global AIDS pandemic seemed insurmountable, with over 2.5 million new HIV diagnoses and two million deaths each year. Since then, significant progress has been made. With unprecedented medical knowledge and tools at our disposal, we finally possess the capability to end HIV as a public health crisis within our lifetimes.

Yet progress must not lead to complacency.

- At least 39 million people are living with HIV – 53% of whom are women or girls.
- The majority of new HIV diagnoses outside of sub-Saharan Africa occur in key populations – including transgender people; gay, bisexual, and other men who have sex with men; people who use drugs; and sex workers – and their sexual partners.
- One in two new HIV diagnoses in the United States occurs in the Southern US.
- Globally, almost half of children living with HIV are not on treatment.

Why You, Why Now?

If these statistics do not resonate with your current priorities, we challenge you to consider the environment that fuels them. The vision of a post-AIDS future remains just out of reach, obstructed by intersecting structural and societal barriers such as stigma and discrimination, economic disparities, racial injustice, gender inequality, anti-LGBTQ laws, criminalization, migration, geopolitical conflict, and inequitable access to healthcare.

We feel confident that these are the very issues on your mind, and those of your grantees and partners. Further yet, more than half of the world's population are electing their leaders in 2024, as a rising tide of authoritarianism and the far right unite racist, homophobic, and anti-human rights actors around the world, and philanthropic and government resources are on the decline.

Effective funding in these turbulent times will take all of us, working together, at the intersection of HIV, health, and human rights.

From January 27-28, 2025, FCAA's Global Philanthropy Summit aims to unite 200 donors and activists in Washington, D.C. to galvanize our collective action toward health, human rights, and justice.

A series of plenary sessions and workshops over two days will:

- Assess the impact of recent elections on the people and places most impacted by HIV;
- Explore the role of philanthropy in this political moment; and,
- Strategize together to protect and strengthen the global HIV response.

It's time to rally together – to engage our peers, educate them on the importance of these issues, and bring them into the fold.

Ending the HIV epidemic can be our collective legacy, but we need more leadership, resources, and political will to turn today's medical potential into tomorrow's lived reality.

With your strong leadership and valuable sponsorship, we will not let this moment pass us by.
